Disclosure of Potential Conflicts of Interest

All authors, reviewers and editors must disclose any association that poses a conflict of interest in connection with the manuscript. As described in the *Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans* (TCPS2, 2018): "A conflict of interest may arise when activities or situations place an individual or institution in a real, potential or perceived conflict between the duties or responsibilities related to research, and personal, institutional or other interests". In the context of publication, examples of possible or potential conflicts of interest include a close personal friendship or family relationship with members on the Editorial Board or a peer-reviewer, certain funding sources (e.g., commercial partners with a vested interest in the research), or ideological, political or religious beliefs that may bias the presentation of the research. Many interests of this sort will be managed effectively through disclosure, either in the text (e.g., explaining one's personal political or religious perspective) or in a declaration of interests (e.g., a funder). More significant conflicts should be managed by creating a critical distance, e.g., recusal of reviewers from a manuscript.
